WVBO'S "GAME OF THEMES EVE AFT" CONTEST OFFICIAL RULES

The Station will conduct the **WVBO's "Game of Themes EVE"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - Contest Period. The Contest entry period will begin at 4:00pm CT on August 26, 2024 and will run weekdays from 4:00pm until 4:30pm through 4:30pm CT on September 5, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. At or around 4:00pm each weekday (each, a "Selection Day"), except Monday, September 2, 2024, the Station will feature a Contest, the station will ask for the fifth caller, as determined by the Station in its sole discretion, to 888-400-1039., who will be the winning caller, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest.
