WWWX'S "COLDPLAY 100824" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained by contacting radio station WWWX ("Station"), 491 South Washburn Street, STE 400, Oshkosh, WI 54904, during available business hours Monday through Friday, on the Station website www.fox969.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **WWWX's "Coldplay 100824"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last 60 Days or a prize valued at \$500 or more in the last six months, and whose immediate family members or household members have not won a prize from the Station in the last 60 days or a prize valued at \$500 or more in the six months Void where prohibited by law. - 2. **Contest Period.** The Contest entry period will begin at 6:00am CT on October 8, 2024 and will continue through 6:00pm CT on October 11, 2024 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. **How to Enter.**
- 4. <u>Text</u>: Send a text message with the announced keyword spelled correctly to 877-369-9769 during the Contest Period. All entries must be received within one hour of the announced keyword to be eligible for a chance to win a prize. Message and data rates may apply. Station has no responsibility for any fees or charges associated with any text messages entrant sends or receives in connection with the Contest. Entrant agrees to receive messages from Station from time to time relating to the Contest, the Station, and any Contest sponsor or prize provider.
- 5. **Verification of Potential Winner.** THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS IS SUBJECT TO VERIFICATION BY STATION WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST. The potential winner must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential winner may be notified by email and/or telephone call after the date of random drawing and/or winner determination. The potential winner will be required to sign and return to Station, within three (3) days of the date notice is sent, an affidavit of eligibility and a liability/publicity release (except where prohibited) to claim the prize, if applicable. A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the

contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. If a potential winner cannot be contacted, fails to sign and return the affidavit of eligibility and/or the liability/publicity release within the required time period (if applicable), or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize.
