WCTO/WWYY/WSJR/WBHD "LUKE BRYAN WEEKEND" CONTEST OFFICIAL RULES

A complete copy of these rules can be obtained at the offices of radio station WCTO/WWYY/WSJR/WBHS ("Station"), 2158 Avenue C, Suite 100, Bethlehem, PA 18017, during available business hours Monday through Friday, Station website www.catcountry96.com, or by sending a self-addressed, stamped envelope to the above address.

The Station will conduct the **Cat Country Network** Contest (the "Contest") substantially as described in these rules, and by participating, each participant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility.
