760 WJR'S "USFL MICHIGAN PANTHERS ON AIR TICKET GIVEAWAY" CONTEST OFFICIAL RULES

The Station will conduct the **760 WJR's "USFL Michigan Panthers ON AIR Ticket Giveaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 9am ET on May 1, 2023 and will run weekdays from 6am until 5pm through 9am ET on May 5, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. Between 9am and 12pm on May 1 and 4, 2023; between 3pm until 5pm on May 2, 2023, and between 6am and 9am on May 3 and 5, 2023 (each, a "Selection Day"), when the Station plays announces the cue-to-call (each, the "Cue"), listeners must call the Station at 800-859-0957. Caller 9 to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. *Time Delay Between Over-the-Air Analog Signal and Internet Broadcast:* Due to the time delay that exists between the Station's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station's analog over-the-air signal. As a result, the odds of an online listener entering this Contest on-air may be diminished. Station's decisions as to the administration and operation of the Contest.
