760 WJR'S "MARINE CITY STAY & PLAY: GREAT TRAILER PARK MUSICAL" CONTEST OFFICIAL RULES

The Station will conduct the **760 WJR's "Marine City Stay & Play: Great Trailer Park Musical Giveaway"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. - 2. Contest Period. The Contest entry period will begin at 6am ET on June 8, 2023 and will run Thursdays from 6am until 5pm through 5pm ET on June 15, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- 3. How to Enter and Win. Listen to the Station during the Contest Period. Between 6am until 9am ET on June 8, 2023 and between 3pm until 5pm on June 15, 2023 (each, a "Selection Day"), when the Station announces the cue-to-call (each, the "Cue"), listeners must call the Station at 800-859-0957. Caller 9 to the Station, as determined by the Station in its sole discretion, will be the winner for that Selection Day after providing the Station the winning listener's name and phone number, subject to verification and compliance with these Contest Rules. All entries may be played on the air. <u>Time Delay Between Over-the-Air Analog Signal and Internet Broadcast</u>: Due to the time delay that exists between the Station 's analog over-the-air signal and the Station's online webcast, listeners who listen to the Station online may hear the cue to call later than listeners listening to the Station of the potential winners are final and binding in all matters related to the Contest. Failure to verify winner's eligibility may result in disqualification and forfeiture of the prize. Unclaimed prizes may not be awarded. [LIMIT ONE PRIZE PER PERSON.]

A winner who returns the affidavit of eligibility and liability/publicity release will be deemed to have accepted the contest prize and thereafter will not be permitted to rescind their acceptance of the prize and/or return the prize. Station's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
